

## 2022-2023 ACADEMIC STEERING COMMITTEE

- Consists of the senate president, serving as chairperson, the senate vice president, the senate secretary, one elected member of the faculty senate from each of the colleges except the honors college and the college of graduate studies;
- for each five elected members to faculty senate beyond five, each college shall have an additional elected member of faculty senate on the committee. ..Elected members serve on the academic steering committee for a term of one year from September first to August thirty-first.
- Five other faculty members serve ex officio as voting members on the academic steering committee by virtue of their positions as chair of the budget and finance committee, the admissions and standards committee, the university curriculum committee, the university faculty affairs committee, and the undergraduate student success committee. These five members serve only during their terms as chairs of their respective standing committees.
- The elected faculty representative to the board of trustees shall serve as an ex officio non-voting corresponding member.
- The president of the university and the provost of the university shall be ex officio, non-voting, corresponding members of the committee. The senate secretary shall serve as secretary of the committee.
