- V. Report of the President of the University

Harlan Sands

President Sands conveyed how complimentary Governor Mike DeWine has been about Cleveland State's mass vaccination clinic; the governor commended Cleveland State again at his news conference yesterday (Tuesday 4.27.21). The President also mentioned that he is lobbying the statehouse to get the state share of university budgets increased to cover inflation. He noted that student applications and acceptances are on the rise; he encouraged faculty to encourage students to register now for classes next fall. President Sands explained that CSU's policy of requiring students residing on campus next fall to be vaccinated may face challenges at the state level. He also referred to Senate Bill 135, that, if passed, would greatly damage four-year universities in Ohio; he and other public university presidents will be working to block passage.

President Sands provided an update on the provost search and the search for the CFO; both searches are progressing on schedule. He also acknowledged the excellent preparation CSU has done for the HLC accreditation visit.

Providing an update on the graduation ceremony at Progressive Field, President Sands mentioned that there will be about 1600 graduates planning on attending, and 75 faculty.

The President thanked everyone for their participation in the CSU 2.0 process and acknowledged the positive energy it was generating in the community and among new faculty hires. President Sands concluded by thanking the faculty for their hard work all semester.

He also reiterated the student concerns about the cost of health insurance premiums for graduate students.

Senator W. Bowen mentioned that this committee will be meeting about the charter for the new Planning and Financial Advisory Committee.

XII. Report of the Provost and Chief Academic Officer Jianping Zhu

Provost Zhu began by thanking all the faculty for a successful spring semester; he is grateful for the faculty's excellent working during this challenging year. He mentioned that the new faculty searches are not quite finished and encouraged faculty participation during these final weeks in the process. He acknowledged the extremely high quality of job candidates we have been receiving in these challenging times for faculty hires at most universities.

The Provost also mentioned the HLC team visit next week and thanked faculty for their hard work in preparing the reports in advance of this visit.

Provost Zhu mentioned the unfortunate surge in COVID cases in India and asked faculty to be alert to potential situations facing our students in India, from India, or with family in India—and to be ready to offer accommodations as appropriate.

The Provost responded to the college caucuses written comments about CSU 2.0, many of which were directed to the lack of detail in the proposal. He asked faculty to trust that the details would eventually be worked out with appropriate faculty input.

Provost Zhu announced that this is his last Senate meeting as provost and thanked everyone for an enjoyable 6 years as provost; he very much appreciated the open and collegial exchanges with the faculty, even on those matters where administration and faculty did not always agree.

XIII. Vote on General Acceptability of the College Reorganization Robert Krebs Proposal in CSU 2.0

Following discussion lasting from 4:08 to 4:52, the vote was taken by individual private message to Faculty Senate admin Jane McCrone.

Senate took a 10-minute recess from 4:55 to 5:05 while the votes were counted

Voting options include "acceptable," "unacceptable," and "abstain." Following discussion lasting from 5:12 to 5:17, the vote was taken by individual private message to Faculty Senate admin Jane McCrone. The motion passed with the following tally (total of 48 votes):

Acceptable/Yes- 39 Unacceptable/No - 5 Abstain - 4

At the conclusion of this vote, President Krebs thanked Faculty Senators for showing that we can be a positive part of change for the future. President Sands expressed his faith in the incredible potential of Cleveland State; he also thanked the Provost and Senate leadership for working behind the scenes to facilitate the productive discussion and debate in advance of the votes.

XIV. Question Time

Questions were asked about the implementation process of CSU 2.0 and how Senate would be involved. President Krebs indicated that this had not been decided fully and he asked for suggestions from senators.

One suggestion was for email discussions by Steering over the summer, as needed.

A question was asked about how the concerns expressed during today's debate about CSU 2.0 would be conveyed to the incoming provost (as yet not selected). President Sands indicated that the deans of colleges being merged have already started those discussions about process and that these decisions could not wait until fall.

A comment was made about the dangers of the Ohio State House Bill 135; both Senator Krebs and President Sands were in agreement about the need for faculty and administrators around the state to push back together against this threat to higher education.

XV. New Business – there being none, the meeting was adjourned at 5:32.
