# WHY ARE WE TOBACCO FREE?



- 1. Out of respect for others and the environment
- 2. To foster a respectful & healthy learning, living, and working environment for our CSU community members
- 3. To address the health risks associated with tobacco use and exposure to secondhand smoke
- 4. To demonstrate the model of a tobacco free workplace for students who may be seeking future employment with tobacco free organizations

#### Please Respect Our Policy

The use of tobacco products (cigarettes, e-cigarettes, cigars, snuff, snus, water pipes, pipes, etc.) is prohibited on all University campus grounds, within cars on campus grounds, & in University facilities owned, leased, used and occupied by CSU. This policy applies to all CSU community members.

### THE FOLLOWING TOBACCO PRODUCTS ARE PROHIBITED:

- Cigarettes
- E-cigarettes/vaporizers
- Cigars
- Snuff
- Chew

- Snus
- Pipes



- Hookahs/Water pipes
- Any other non-combustible

tobacco product

### WHY ARE E-CIGARETTES INCLUDED IN THE POLICY?

- Many E-cigarettes contain tobacco and other harmful substances.
- E-cigarettes have not been approved or regulated by the FDA as a tobacco cessation resource.
- We cannot tell which E-cigarettes contain tobacco upon observation, so we must prohibit use of all of them.
- E-cigarettes can look like cigarettes to observers, which perpetuates the idea that tobacco use is allowed on campus.

#### CSU'S TOBACCO POLICY: WHERE IS SMOKING PROHIBITED?



- ALL CSU-owned roads and their adjacent sidewalks, which include:
  - E 24th North of Euclid, in front of Fenn Tower
  - o E 24th through Euclid Commons
  - E 19th South of Chester, to the campus Police Station
  - E 25th & E 25th St. Place at Plant Services
  - The alley adjacent to Mather Mansion through to Chester
  - The walk in front of the student center
- All campus areas where <u>CSU buildings over-hang or cover streets and walks</u>.


#### CSU'S TOBACCO POLICY: WHERE IS SMOKING PROHIBITED?

- Current state-wide smoking restrictions within 20 feet of any CSU building entrance, including CSU buildings with an entrance from a public sidewalk, remain in effect.
- Smoking is prohibited within University owned & private vehicles parked on CSU property.
- There are no designated smoking areas on campus.

#### WHERE IS SMOKING NOT IN VIOLATION OF OUR TFC POLICY?



- Public streets and sidewalks passing through campus "that are not owned or maintained by CSU" are not included in policy enforcement and are not in violation of our Tobacco Free Campus (TFC) policy.


### HOW TO APPROACH SOMEONE USING TOBACCO ON CAMPUS:

- Use a consistent script: this leads to consistent enforcement and helps create an environment of respect and compliance.
- Make sure all visitors, students, & employees feel welcome at CSU and are given a polite notice of our TFC policy the first time.
- Use a firm, polite, and compassionate approach don't be aggressive but do not apologize
- Offer a Tobacco Free Hotcard if they request more information about enforcement or tobacco cessation resources

# SITUATION: YOU SEE SOMEONE USING TOBACCO PRODUCTS ON CAMPUS



Response: "Hello, my name is \_\_\_\_\_ and I am an (employee, student) here at Cleveland State. I want to let you know that we are a tobacco free campus, meaning that using tobacco products is prohibited on our grounds. Please put your cigarette out and dispose of it in a trash can or move to a public sidewalk. Thank you for your cooperation."



#### **QUESTION:**

### "WHERE AM I ALLOWED TO SMOKE?"

Response: "Cleveland State became a tobacco free campus Fall 2013, prohibiting tobacco use of any kind. The use of tobacco products is not allowed anywhere on the campus. If you choose to smoke or use tobacco products, you will need to leave the campus or move to a public sidewalk. Thank you for respecting our policy."

Action: Give them a Hotcard as a reference to where the policy is and isn't enforced

#### SITUATION:

#### GIVING NOTICE TO PROSPECTIVE STUDENTS AND THEIR FAMILIES

**Communication:** You want to proactively communicate that Cleveland State is a tobacco free campus to prospective employees, students and their families.

Response: "I'd like to let you know in advance of your visit that Cleveland State is a tobacco free environment. The use of tobacco products is not allowed on our property, grounds, or parking areas. Thank you for respecting our policy."

### To Respect & Educate Not to Punish



- We want all students, faculty, and staff to feel welcome to CSU.
- Considering there is no safe level of secondhand smoke and that many of our CSU
  community members have health issues that smoking exacerbates, we need everyone
  to respect the TFC policy.
- Each individual needs to be approached and educated about the TFC policy and areas in which smoking is and is not prohibited before submitting a violation form.
- The TFC Violation and Incident Report form was created to report individuals who
  have already been approached and continue to violate the policy.

#### THE CSU TOBACCO FREE VIOLATION FORM:

#### When should you fill out the form?

When you see a repeated violator on campus

#### What information should you include on the form?

- The date, time, and specific location of the violation
- Detailed description of the violator(s) seen
- Provide as much detail & description of the violator as possible. (including if you think they are a student, faculty, staff, construction worker, visitor, etc.)
- The TFC Violation and Incident Report form is located on our website at <u>www.csuohio.edu/tobaccofree</u>.

#### What if I feel threatened when approaching a violator?

- Call CSU Police Department at 216-687-2020
- If you approach a group of repeat violators who refuse to comply, call CSU Police Department at 216-687-2020





### CORRECTIVE ACTION FOR STAFF:

Staff found in violation of the CSU Tobacco Free Campus Policy will be reported to the Manager of Labor Relations in the Department of Human Resources, Danielle Ruiz and to the Manager of VikeHealth & Well-Being, Lisa Sandor. The violator's supervisor will be notified and violators will be subject to corrective action. The name of the person reporting the violator will not be disclosed.

# CORRECTIVE ACTION FOR FACULTY:

Faculty found in violation of the CSU Tobacco Free Campus Policy will be reported to the Manager of Labor Relations, Danielle Ruiz and to the Manager of VikeHealth & Well-Being, Lisa Sandor. The Vice Provost of Faculty Affairs, William Morgan, will be notified as well as the faculty's supervisor. Violators will be subject to corrective action. The name of the person reporting the violator will not be disclosed.

# CORRECTIVE ACTION FOR STUDENTS:

Students found in violation of the CSU Tobacco Free Campus Policy will be reported to the Director of Student Conduct & Advocacy, Valerie Hinton-Hannah in the Department of Student Life. Violators will be subject to corrective action through the Student Code of Conduct. The name of the individual reporting the student needs to be included in order to notify the violator.

#### To report students, the form will be routed to:

Director of Student Conduct & Advocacy and Manager of VikeHealth & Well-Being

Visitors and/or individuals who are University contractors will be routed to the appropriate Plant Services Facilities & Safety Administration Account Clerk 2, Randy Bowling, or Campus Support Services supervisor.
